**Registration forms and discounted fees must be postmarked by Friday, July 8, 2016. Registration received after July 8, 2016 incurs an additional fee of \$50.00 per child.** If you don't respond, we will assume your child will not be enrolled with the Kinnikinnick School District and your child's name will not appear on a class list.

Enclosed are the following forms:

1. Pre-printed Registration Form
  - Make corrections on any missing or incorrect information.
  - Return **one registration form per child.**
2. Transportation Application
  - Fill in **one transportation form for each child.**
3. Authorized Use Policy and Student Handbook Forms
  - **Each form one per child.**
4. Residency Certification
  - Annual verification of residency is required **per family.**
5. Fee Form
  - **One fee form needed per family.** Fill in amounts for each child and make check payable to Kinnikinnick CCSD #131.
  - All Schools (K-8): Will use a debit system for lunch purchases. We suggest starting your debit system with \$20.00 in order to avoid deficiencies early on.

**New Student registration will be held on July 19th and July 26th from 4:00 pm - 8:00 pm at Roscoe Middle School, 6121 Elevator Road, Roscoe, IL 61073.**

#### **Application for Waivers**

The District maintains a Registration fee waiver application process to waive registration fees for families that qualify. Fee waiver applications must be requested annually. Please mark box on enclosed fee sheet if you are requesting a fee waiver and not including registration fees. Applications will be sent out and you are required to submit proof of income with your returned applications. If you do not submit proof of income, you will be notified that your application has been denied and you are required to pay fees. The District will notify you if your waiver is approved.

#### **Free and Reduced Lunch Application**

The Application for Free and Reduced Price Meals will be mailed in August to those currently enrolled in the program. If you were enrolled last year, you will automatically receive a new application this year. If you are not enrolled and feel you qualify, please contact Lynn McGill in the District Office at (815) 623-2837, ext. 6163 for an application.

#### **Physicals, Dental and Vision Exams**

Illinois state law requires Illinois physicals and immunizations upon entry into PK/ECH, Kindergarten, 6<sup>th</sup> and students new to Illinois schools. For all students required to have a current physical, the physical can be returned with payment and registration. Also required for kindergarten, 2<sup>nd</sup>, and 6<sup>th</sup> grade students is a dental exam. A vision exam is required for kindergarten students. For more detailed information refer to the enclosed health notice. **Students will not be assigned a homeroom nor allowed to attend school until proof of IL physicals and immunizations are in compliance.**

**PK-5<sup>th</sup> Homeroom/Teacher Assignments** will be emailed to the email address on file by Friday, August 12, 2016 after 3:00 p.m. For individuals that do not have an email address on file, you may contact the school office on Monday, August 15<sup>th</sup>. **6-8<sup>th</sup> grade schedules will be released at the grade level Orientation.**
