Mrs. Freedlund gave the Superintendent's report. Mrs. White, Mrs. King, and Mr. Diaz will represent the BOE at the June 6, 2014 8th grade promotion ceremony. Mrs. Freedlund tabled information on teacher evaluation. Mrs. Freedlund announced the use of the Power Works web based professional development program that will be implemented next school year. The system houses and tracks all State mandated trainings for staff, student and staff accident reporting and SDS chemical sheets. Mrs. Bannon will also be rolling out a summer professional development opportunity for teachers on June 11th and 12th that will continue the process of implementing the student growth component into student assessments. Mrs. Freedlund informed the BOE that the Superintendents of Boone and Winnebago Counties have sent a letter to Illinois State School Superintendent Christopher Koch and our local politicians in support of the Common Core

Standards and assessments aligned for student growth but a request to slow down the PARCC implementation timeline and allow for continued transition in a "no stakes" pilot format due to various issues outlined in the letter.
