**MOTION #1. APPROVE THE REGULAR AND CLOSED SESSION SCHOOL BOARD MEETING MINUTES OF OCTOBER 26, 2017, NOVEMBER 2017 PAYABLES IN THE AMOUNT OF \$386,501.07, OCTOBER 2017 PAYROLL DEDUCTIBLE EXPENSES AND ACH WIRES IN THE AMOUNT OF \$479,455.59, OCTOBER 2017 PAYROLLS IN THE AMOUNT OF \$637,135.62, AND THE TREASURER’S REPORT FOR OCTOBER 2017.**
