Mrs. Freedlund provided her report. Staffing continues to be an area of need for the District in both areas of non-certified and certified positions. A partnership is being explored with Global Network Recruiters for the position of psychologist for the 2022-23 school year. Another possibility is also being explored with Northern Illinois University, ProPEL- which partners with districts to cohort paraprofessionals to obtain their teaching license in Special Education. This program may be fully grant funded which would be an excellent opportunity for our paraprofessionals. The District began COVID-19 testing of employees following the Executive Order on testing. Mrs. Freedlund complimented our staff for continuing to keep our focus on students and comply with the order to ensure that in person education remains in place for the District.
