Student 12-2012-7-L shall attend the Regional Learning Academy (RLA) program. The Board shall pay the tuition cost for the RLA program but the parents of Student 12-2012-7-L shall be responsible for transporting Student 12-2012-7-L to and from and the RLA program. In the event Student 12-2012-7-L does not engage in any of the Prohibited Student Conduct set forth in Board of Education Policy 7:190, paragraphs 1 through 4, from December 10, 2012, through the beginning of the 2013-14 school year, Student 12-2012-7-L's expulsion shall terminate upon the beginning of the 2013-14 school year and Student 12-2012-7-L must successfully complete the Drug Alcohol and Family Assistance program and file a certificate of completion with the Superintendent.
